# EASY WIRE BURNING KIT

---

Kit Includes:

- 2 - Maple Handles with quick-loop hooks
  - 9 Easy Burn Wires
- 3 each 6" Wires: 1 - .016 Red, 1 - .020 White, 1 - .026 Blue  
3 each 9" Wires: 1 - .016 Red, 1 - .020 White, 1 - .026 Blue  
3 each 18" Wires: 1 - .016 Red, 1 - .020 White, 1 - .026 Blue

**Choose the length** of wire by the project you are turning:

6" Wires are suggested for pen turners and small spindle work.

9" Wires are suggested for medium size spindles such as handles and pepper mills.

18" Wires are suggested for large projects such as bowls and platters.

**Adding a small groove** in your project to locate your burn line is recommended. The Easy Detailer Tool is the perfect tool for this job. It is very easy to control the width and depth of your burn line if you follow this practice.

**Connect the wire** of your choice to the handles using the quick-loop hooks. Hold the wire to the spinning wood with moderate pressure until friction heats the wire and burns a line in the wood. Smoke will often appear and is normal. Do not overheat / over-burn the line. Practice on a scrap piece of wood until you attain the result you are looking for.

**USE CAUTION!** The wire is very hot! Even after just one burn, the wire becomes very hot. Handle carefully and use caution when laying the burner down after use. Be aware of wood chips and dust in the area as of course they are very flammable. **USE CAUTION!**

Under normal use this kit and the wires provided should last for many years to come.
